

## **OFFICIAL CONTEST RULES, TERMS & CONDITIONS**

## Brought to you by American College of Education

NO APPLICATION OR PURCHASE IS NECESSARY TO ENTER OR WIN. AN APPLICATION OR PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility: Drawing or Contest (the Drawing or "Contest") is open to those who fill out an American College of Education entry form at the web address specified, or satisfy all contest participation instructions as applicable, and who are 18 years and older as of the date of entry. The Contest is only open to legal residents of the United States and is void where prohibited by law. Employees of American College of Education (the "Sponsor") their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state and local laws and regulations.
- **2. Agreement to Rules:** By participating, you agree to be fully, unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. How to Enter: To enter the Drawing or Contest, participants must fill out an American College of Education Contest entry form using the specified form provided on American College of Education's website (ace.edu), or satisfy all contest participation instructions as applicable. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of American College of education. You may enter only once, and you must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
